The Rise and Fall of the Japanese Imperial Naval Air Service Peter J. Edwards, 2010-11-20 This book describes in considerable detail the people, events ships and aircraft that shaped the Air Service from its origins in the late 19th century to its demise in 1945. The formative years began when a British Naval Mission was established in Japan in 1867 to advise on the development of balloons for naval purposes. After the first successful flights of fixed-wing aircraft in the USA and Europe, the Japanese navy sent several officers to train in Europe as pilots and imported a steady stream of new models to evaluate. During World War One Japan became allied with the UK and

played a significant part in keeping the German fleets of ships and submarines at bay in the Pacific and Indian Oceans. However, in the international naval treaties that followed they felt betrayed, since the number of capital ships, battleships and cruisers, that they were allowed was below those of the USA and the UK. Aircraft carriers were not included, so a program of carrier building was started and continued until World War Two. At the same time they developed an aircraft industry and at the beginning of war their airplanes were comparable, and in some instances superior, to those of the British and Americans. Much prewar experience was gained during Japan's invasion of China, but their continued anger with America festered and resulted in their becoming allied with Germany, Italy and the Vichy France during World War Two. There followed massive successful attacks on Pearl Harbor, the Philippines, the Southern Islands, Port Darwin and New Guinea. The British were decimated and the USA recoiled at the onslaught, taking over a year to regroup and take the war to the Imperial Japanese forces. Throughout the conflict many sea battles were fought and the name Zero became legendary. When Japan eventually capitulated after the Atomic bombs were dropped the Japanese Imperial Air Service was disbanded.

Hotchkiss Machine Guns John Walter, 2019-11-28 Created by a long-forgotten Austrian nobleman, Adolf Odjek von Augzd, the air-cooled Hotchkiss machine gun was the first to function effectively by tapping propellant gas from the bore as the gun fired. Although the Hotchkiss would be overshadowed by the water-cooled Maxim and Vickers Guns, it proved its effectiveness during the Russo-Japanese War. The gun, quirky though it was, was successful enough to persuade Laurence Benét and Henri Mercié to develop the Modèle Portative: a man-portable version which, it was hoped, could move with infantrymen as they advanced. Later mounted on tanks and aircraft, it became the first automatic weapon to obtain a 'kill' in aerial combat. Though it served the French and US armies during World War I (and also the British in areas where French and British units fought alongside each other), the Odjek-Hotchkiss system was to have its longest-term effect in Japan. Here, a succession of derivatives found favour in theatres of operations in which water-cooling could be more of a liability than an asset. When US forces landed on Saipan, Guam and Iwo Jima, battling their way from island to island across the Pacific, it was the 'Woodpecker' - the Type 92 Hotchkiss, with its characteristically slow rate of fire - which cut swathes through their ranks. Supported by contemporary photographs and full-colour illustrations, this title explores the exciting and eventful history of the first successful gas-operated machine gun.

B-25 Mitchell vs Japanese Destroyer Mark Lardas, 2021-12-23 Throughout the first year of the war in the Pacific during World War II the USAAF was relatively ineffective against ships. Indeed, warships in particular proved to be too elusive for conventional medium-level bombing. High-level attacks wasted bombs, and torpedo attacks required extensive training. But as 1942 closed, the Fifth Air Force developed new weapons and new tactics that were not just effective, they were deadly. A maintenance officer assigned to a B-25 unit found a way to fill the bombardier's position with four 0.50-cal machine guns and strap an additional four 0.50s to the sides of the bomber, firing forward. Additionally, skip-bombing was developed. This called for mast-top height approaches flying the length of the target ship. If the bombs missed the target, they exploded in the water close enough to crush the sides. The technique worked perfectly when paired with "strafe" B-25s. Over the first two months of 1943, squadrons perfected these tactics. Then, in early March, Japan tried to reinforce their garrison in Lae, New Guinea, with a 16-ship convoy – eight transports guarded by eight destroyers. The Fifth Air Force pounced on the convoy in the Bismarck Sea. By March 5 all eight transports and four destroyers had been sunk. This volume examines the mechanics of skip-bombing combined with a strafing B-25, assessing the strengths and weaknesses of the

combatants (B-25 versus destroyer), and revealing the results of the attacks and the reasons why these USAAF tactics were so successful.
