Simple Lie Algebras Over Fields of Positive Characteristic: Structure theory Helmut Strade,2004 The problem of classifying the finite-dimensional simple Lie algebras over fields of characteristic $p > 0$ is a long-standing one. Work on this question during the last 45 years has been directed by the Kostrikin-Shafarevich Conjecture of 1966, which states that over an algebraically closed field of characteristic $p > 5$ a finite-dimensional restricted simple Lie algebra is classical or of Cartan type. This conjecture was proved for $p > 7$ by Block and Wilson in 1988.
