ITBL IS A JAPANESE NATIONAL PROJECT STARTED IN 2001 WITH THE OBJECTIVE OF REALIZING A VIRTUAL JOINT RESEARCH ENVIRONMENT USING INFORMATION TECHNOLOGY. ITBL AIMS TO CONNECT 100 SUPERCOMPUTERS LOCATED IN MAIN JAPANESE SCIENTIFIC RESEARCH LABORATORIES VIA HIGH-SPEED NETWORKS. A TOTAL OF 58 TECHNICAL CONTRIBUTIONS FROM 11 COUNTRIES WERE SUBMITTED TO ISHPC-V. EACH PAPER RECEIVED AT LEAST THREE PEER REVIEWS. AFTER A THOROUGH EVALUATION PROCESS, THE PROGRAM COMMITTEE SELECTED 14 REGULAR (12-PAGE) PAPERS FOR PRESENTATION AT THE SYMPOSIUM.
